3/5/EXT/38/Scheme/2016-17/D.Agri/385

The scheme Human Resource Development in Agriculture notified vide No. 3/5/EXT/38//SCHEME/2013-14/D.AGRI/381 dated 11-9-2013

is duly amended with approval of the Government and hereby published for general information of public.

- 1. *Short title & commencement.* (*i*) This scheme shall be called "Human Resource Development in Agriculture".
- (*ii*) Amendments to this modified scheme shall come in force with immediate effect and shall remain in force till it is withdrawn.
- 2. Objective of the scheme.— (i) To encourage farmers in upgrading their skills, technology dissemination, capacity building through training and exposure visits and to create awareness of the developmental schemes in agriculture.
- (*ii*) To organize Workshops, Exhibitions, Krishi Melas, Krishi Mahotsav, Seminars, for fruitful interaction and to expose the farmers to latest technology machinery, equipments, inputs and to demonstrate their uses.
- (iii) To support education in Agriculture and allied sector.
- 3. The scheme of Human Resource Development in Agriculture shall be operated with following components.—
- 3.1 Off Campus Training.— Training shall be conducted on various local issues in agriculture and home science including integrated farming by deputing team of experts from the Department to the villages. This will address the local problems of the farmer in association with Krishi Vigyan Kendra/ATMA. The training would be for one day. Trainings would be conducted in the field, temple, homes of farmers, church premises, schools etc.

Eligibility for Training Programme.— Any farmer, land owner, agricultural labourer, members of farmers clubs, students, members of women self help group etc., who have interest in agricultural programmes.

Pattern of assistance.— Each training shall consist of 20-40 beneficiaries for agriculture and Home Science and camps conducted separately. Training shall be conducted by Departmental Officers. However for specific local problem if an expert besides Department

officials is required to be hired the same shall be hired with honorarium of Rs. 1500/- per day. The maximum expenditure would be to the maximum extent of Rs. 300/- or actual per farmer for training material, inputs for demonstration working tea/lunch/dinner for the participants, sound system, chairs, POl etc.

# 3.2 Study tour of farmers.—

Study tour of farmers outside State.— Study tours shall be organized for farmers, extension officers, policy makers, to visit Research Stations, Agriculture Universities Progressive Farmers and centres of excellence outside the State. This would expose them to latest technology in agriculture and allied fields, and an opportunity to see good practices being followed by Progressive Farmers elsewhere.

Eligibility.— The farmers cultivating land which is his own or leased or on rent, agriculture officers of the Department, Horticulture Corporation or other line departments, students studying in agriculture subjects, member of farmers clubs, agri. co-operatives with due recommendation of the Zonal Agricultural Officer of the area.

Each of the trainee would be provided stipend of Rs. 800 per day towards the lunch, refreshment, and lodging charges. The bus or train fare upto 3 tier A. C. shall be paid or as per the actual.

3.3 Workshops/Exhibition/Seminars/Krishi Mela.— Workshops, Exhibitions, Seminars, Krishi Mela, Krishi Mahotsav are conducted by the department and various Government and Non-Government organizations/training institutes to create awareness and demonstrate new innovation in agriculture to farmers.

Exhibitions shall be conducted on various issues of Agriculture and allied sectors by Department of Agriculture. The same may also be sponsored if organized by NGO/Voluntary Organizations/Farmers Clubs & other professional agencies.

Farmers Club, NGOs or voluntary organizations or professional institutes organizing Workshop/Exhibitions/Seminars and desiring to avail benefit should be a registered body and shall be required to submit their duly audited Statement of Accounts for last 3 years for availing the sponsorship.

Wherever the events are required to be sponsored, Department will provide maximum assistance of 50% of the cost with specific approval of Government upon receipt of detail proposal.

3.4 Support for education in Agriculture.— Since there is no Agriculture College in the State, the children of the Farming Community find it difficult to obtain degree in Agriculture. Therefore reservation of seats outside the State is arranged by Government of Goa by signing a tripartite agreement. Every year nine No. of students are sponsored by the State for which financial provisions is made in this scheme.

*Objective.*— Facilitate the students from Goa to obtain degree in Agricultural and allied courses.

Pattern of assistance proposed.—

Pattern of assistance for Graduation B.Sc (Agri/Hort):—

An amount of Rs. 10,000/- per year/per seat for degree course studies are required to be given to the University as per the agreement.

Educational support of Rs. 3,000/- per month for undergraduate students during entire period of study for maximum 4 years provided that they pass out satisfactorily in each semester.

Pattern of assistance for Post Graduation M.Sc (Agri/Hort):—

Educational support of Rs. 3,000/- per month for post graduate students during entire period of study shall be provided to those who get admission in Post Graduation Courses on their own merit. The support would be provided only if they pass out satisfactorily in each semester.

Eligibility/criteria for selection and conditions of study.— (1) The candidates should apply in the prescribed proforma Annexure I.

- (2) The candidates should be resident of Goa for minimum period of 15 years.
- (3) The selection will be based on merit. Percentage aggregate marks for PCB of qualifying exam shall be taken as points and weightage would be given as below:—
  - (a) Student coming from agricultural family having land in his/her name or in name of his/her parent or paternal parent as seen in land index form I & XIV for B. Sc. (Agri.)//(Hort.)—10 points.
  - (*b*) Student coming from fishing families for B. Sc. (Fish) duly certified by the Mamlatdar—10 points.
  - (c) Student holding NCC "B" or "C" certificate or NSS camp with aggregate 240 hrs.—2 points.
  - (*d*) Student who has participated in inter collegiate games/sports —2 points.
  - (e) B.Sc. degree holders seeking admissions to undergraduate degree in agriculture or allied subject 6 points.
    - (f) Maximum added points 20 points.
- (4) The selected candidates will have to make his/her own arrangements for stay at the institution of studies either through hostel or their own.
- (5) The selected candidates should make their own arrangements for travel from Goa to the college of studies.
- (6) The candidate should attach the attested photo copies of the marks list of XIIth Science, school leaving certificate, the residential certificate and birth certificate and other certificates as applicable.

- (7) The selected candidate will pay all his tuition fees, hostel fees, and deposits as applicable to the students on his/her own after the final selection and admission of the College.
- (8) The selected candidate will have to furnish a security deposit of Rs. 2,000/- to this Directorate in form of Demand Draft drawn on any Nationalized Bank payable at Panaji in the name of Director of Agriculture, Caranzalem to affirm his/her candidature at the time of acceptance.
- (9) The security deposit of the candidates will be forfeited in favour of the Government for his/her failure to report to the college within the stipulated time or for abandoning the study in the middle of year.
- (10) The security deposit will be refunded to the applicant after one year of successful completion of the studies duly supported by a letter from the college of studies to that effect.
- (11) The candidates will be required to undergo medical fitness test as directed by the college of studies.
- (12) The selected candidates will have to abide to all the terms and conditions of admission, study, behavior, discipline, etc., as specified from time to time by the college and the Directorate of Agriculture, Goa. The selected candidates will have to execute a bond on Rs. 50/- non-judicial stamp paper affirming to adhere to these conditions.
- (13) After completion of admission formalities the students should immediately submit a copy of admission fee receipt to this Directorate.

Financial requirement.— The various programmes as indicated in the preceding paras shall be implemented subject to availability of funds for farmer under general category Scheduled Tribe farmers and Scheduled Caste farmers.

Relaxation.— The Government shall be empowered to relax any or all clauses or

conditions of the scheme in genuine cases. However for release of financial assistance in such case will be considered only with approval of Finance (Exp.) Department.

*Interpretation.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision shall lie with the Government, which shall be final and binding on all concerned.

Redressal of grievances and disputes.—Grievances if any, arising out of the implementation of this scheme, shall be heard and decided by the Minister for Agriculture and the decision of the Minister for Agriculture in this regard shall be final and binding on all concerned.

### **Notification**

No. 56/Symbol/2016/PPS-II— In exercise of the powers conferred by Article-324 of the Constitution of India read with section 29A of the Representation of the People Act, 1951, section 21 of the General Clauses Act, 1897, Rules 5 and 10 of the Conduct of Elections Rules, 1961, and all other powers enabling the Commission in this behalf, the Election Commission of India hereby makes the following Order to further amend the Election Symbols (Reservation and Allotment) Order, 1968, namely:—

- 1. Short title and commencement.— (i) This Order shall be called the Election Symbols (Reservation and Allotment) (Amendment) Order, 2016.
- (ii) It shall be deemed to have come into force with effect from 1st January, 2014, and

shall always be deemed to have been so effective.

2. Amendment of Paragraph-6C.— The existing Paragraph-6C of the Election Symbols (Reservation and Allotment) Order, 1968 shall be substituted as follows:—

"6C-Conditions for continued recognition as a National or State Party.— (1) Notwithstanding anything in Paragraph 6A and Paragraph 6B, if a political party recognized as a State Party or National Party fails to fulfil the conditions of Paragraph 6A or, as the case may be, Paragraph 6B, at the next general election to the House of the People or, as the case may be, to the Legislative Assembly of the State, following the general election to the House/Assembly concerned on the basis of which it got recognition (hereinafter referred to as "the next election"), it shall continue to be treated as recognized State Party or National Party, as the case may be.

(2) If a recognised political party continues to be treated as recognised National Party or State Party after the next election to the House of the People or, as the case may be, to the Legislative Assembly of the State under the provisions of sub-paragraph (1), the question whether it shall further continue to be so recognised after any subsequent general election to the House of the People or, as the case may be, to the Legislative Assembly of the State concerned, shall be subject to the fulfillment by the party of the conditions specified in Paragraph-6A or 6B, as the case may be."

# 2. पैराग्राफ-6ग का संशोधन

The following draft rules which the Government of Goa proposes to make so as to further amend the Goa, Daman and Diu Land Revenue (Record of Rights and Register of Cultivators) Rules, 1969, are hereby pre-published as required by sub-section (3) of section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969), for information of the persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration by the Government on the expiry of fifteen days from the date of their publication in the Official Gazette.

All objections and suggestions to the said draft rules may be forwarded to the Secretary (Revenue) to the Government of Goa, Revenue Department, Secretariat, Porvorim, Goa, before the expiry of the said period of fifteen days so that they may be taken into consideration at the time of finalization of the said draft rules.

## DRAFT RULES

In exercise of the powers conferred by sub-sections (1) and (2) of section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa, Daman and Diu Land Revenue (Record of Rights and Register of Cultivators) Rules, 1969, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Goa Land Revenue (Record of Rights and Register of Cultivators) (Amendment) Rules, 2016.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Amendment of rule 10.— In rule 10 of the Goa, Daman and Diu Land Revenue (Record of

Rights and Register of Cultivators) Rules, 1969, (hereinafter referred to as the "principal Rules"), in sub-rule (1),—

- (i) for clause (ii), the following clause shall be substituted, namely:—
  - "Land is acquired under any law for the time being in force dealing with the acquisition of land".
- (ii) the second proviso thereof, shall be omitted.
- (*iii*) after sub-rule (*1*) the following "Explanation" shall be inserted, namely:—
  - "Explanation: The words 'persons interested' in this rule shall mean and include the person/s from whom the occupancy right is accrued to the applicant who has applied for the mutation."
- 3. Amendment of rule 12.— In rule 12 of the principal Rules for the expression "Incase all the notices are served to the persons interested in land and" the expression, " After the objection period is over and if" shall be substituted.
- 4. Amendment of rule 14.— In rule 14 of the principal Rules the expression "on payment of fees as mentioned in section 96 of the Code" shall be omitted.
- 5. *Amendment of rule 15.* For rule 15 of the principal rules, the following rule shall be substituted, namely:—
  - "15. Intimation of Transfers by registering officer and giving effect to such transfer in record of rights.— (1) When any document purporting to create, assign or extinguish any title to, or any charge on, land used for agricultural purposes, or in respect of which a record of rights has been prepared is registered under the Indian Registration Act, 1908 (Act 16 of 1908) the officer registering the document shall accept the application for mutation addressed to concerned Mamlatdar alongwith the mutation fees as specified in section 96 of the Code and shall send intimation to the Mamlatdar of the Taluka in Form XIII along with the duplicate

copy of the document, registered by him in respect of lands included in each village. Such intimation shall be given immediately on registration of the document and in any case within a period of three working days.

- (2) On receipt of an intimation under sub-rule (1), the *Mamlatdar* shall immediately take action as if the intimation was a report made to him under section 96 of the code and he shall proceed to dispose such cases under these rules.
- 6. *Insertion of new rule 15-A.* After rule 15 of the principal Rules, the following rule shall be inserted, namely:—
  - "15-A. *Disposal of the mutation applications online.* (1) All the applications and intimations received from the Civil Registrar under Rule 15 shall be entered in an online mutation system by the Mamlatdar on day to day basis;
  - (2) Entry made under sub-rule (1) shall be disposed in the sequential manner. Any change in disposal of cases in the sequence maintained in the system shall be only on specific approval of the Collector.
  - (3) In case due to any reason the Mamlatdar is not in position to dispose the earlier entry, he is required to submit a brief note on line to the Collector seeking his approval for disposal of subsequent entry//entries. On receiving such request the Collector, if satisfied, shall grant the permission on line within two days".
- 7. Amendment of rule 19.— In rule 19 of the principal Rules for the expression "the Talathi shall make an entry" the expression "the

Talathi shall intimate to the Mamlatdar for making an entry" shall be substituted.
